- 1.4 Researching, collecting and recording information

Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence is required to show that the learner has met the Outcomes and Assessment Standards. Learners are required to demonstrate the skills in each of the Assessment Standards and teachers/lecturers must gather evidence of the attainment of these skills in appropriate ways.

This Unit requires the learner to develop a range of researching skills. The Unit focuses on the processes relevant to undertaking independent research. Evidence for this Unit may be generated through a range of activities, such as:

- completing checklists/folios/logbooks
- interviews undertaken by the assessor
- preparing interim reports while undertaking research
- presentations to the assessor or to other learners
- assessor observation

The assessor may use a checklist during learners' interviews or presentations. The evidence may be collected and retained in a variety of forms, including written records and audio or digital recordings.

Evidence may be presented for individual Assessment Standards or gathered for the Unit as a whole.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Course/Unit Support Notes*.

Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below.
