Unit outline

The general aim of this Unit is to develop research skills and a basic knowledge and understanding of key aspects of developed and developing countries.

Learners who complete this Unit will be able to:

- 1 Use research skills in the context of developed and developing countries
- 2 Draw on basic knowledge and understanding of human environments in developed and developing countries

This Unit is a mandatory Unit of the National 3 Geography Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes* which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in the *Unit Assessment Support*.

Recommended entry

Outcomes and Assessment Standards

Outcome 1

The learner will:

- 1 Use research skills in the context of developed and developing countries by:**
 - 1.1 Collecting a limited range of basic geographical information about a developed and a developing country
 - 1.2 Comparing a limited range of geographical information

If Units are taken as a part of a Course, then the evidence for 'mapping skills', 'research skills' and 'skills in the use of graphical and numerical information' may be presented in the context of any of the three Units of the Course.

Outcome 2

The learner will:

- 2 Draw on basic knowledge and understanding of human environments in developed and developing countries by:**
 - 2.1 Briefly describing differences between a developed and a developing country
 - 2.2 Briefly describing factors influencing population change in a developed or developing country
 - 2.3 Briefly describing land use in an urban or rural area in a developed or developing country

Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence is required to show that the learner has met the Outcomes and Assessment Standards.

A limited range of geographical issues should be studied which demonstrate a contrast between a developed and a developing country. However, learners need only demonstrate achievement of Assessment Standards in one context.

A range of research skills may be developed in this Unit such as the use of: field work, field sketches, photographs, maps, graphs, secondary data, internet, questionnaires and field work surveys.

If this Unit is taken as part of a Course, mapping skills may be used instead of research skills to generate evidence of successful achievement of the Outcome.

Assessment evidence can be drawn from a variety of activities and presented in a variety of formats, including, for example, presentations, posters, brief written responses to questions, and participation in group tasks. All of the evidence does not need to be from the one activity, but can be assembled from a variety of tasks and assessments carried out during the duration of the Course.

Evidence may be presented for individual Outcomes or gathered for the Unit, Units or Course as a whole by combining assessment holistically.

Exemplification of assessment is provided in the *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below.
