## Gaelic (Learners): Using Language (National 4)

**SCQF:** level 4 (9 SCQF credit points)

### Unit outline

The general aim of this Unit is to provide learners with the opportunity to develop talking and writing skills in Gaelic and to develop their knowledge of straightforward language in the contexts of society, learning, employability, and culture.

Learners who complete this Unit will be able to:

- 1 Use straightforward spoken Gaelic in conversations
- 2 Use straightforward written Gaelic

This Unit is a mandatory Unit of the National 4 Gaelic (Learners) Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes*, which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in *Unit Assessment Support*.

The *Added Value Unit Specification* for the National 4 Gaelic (Learners) Course gives further mandatory information on Course coverage for learners taking this Unit as part of the National 4 Gaelic (Learners) Course

For this Unit, learners will be required to provide evidence of their talking and writing skills by:

- ◆ using straightforward spoken language in at least one conversation
- ◆ using straightforward written language in at least one activity

Assessment generated for this Unit must come from one of the following contexts: society, learning, employability, or culture.

Evidence should be gathered in combination with other Outcomes where possible, either from this Unit or in combination with the Outcomes from the Unit *Gaelic (Learners): Understanding Language* (National 4). Evidence may also be gathered for individual Outcomes where appropriate
