Unit outline

The general aim of this Unit is to develop learner's skills in evaluating historical sources. Learners will apply knowledge and understanding of important events and themes within a specific context of Scottish history.

Learners who complete this Unit will be able to:

- 1 Use a range of basic historical sources of information to evaluate their usefulness
- 2 Draw upon a basic factual knowledge and understanding of important historical events

This Unit is a mandatory Unit of the History (National 4) Course and is also available as a free-standing Unit. The Unit specification should be read in conjunction with the *Unit Support Notes* which provides advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in the *National Assessment Resource*.

The Added Value Unit Specification for the History (National 4) Course gives further mandatory information on Course coverage for learners taking this Unit as part of the History (National 4) Course.

Recommended entry

Entry to this Unit is at the discretion of the centre. However, learners would normally be expected to have attained the skills, knowledge and understanding required by one or more of the following or equivalent qualifications and/or experience:

- ◆ Access 3 History or relevant component Units or another social subject
- ◆ Literacy (SCQF level 3)
- ◆ equivalent qualifications

Outcome 1

The learner will:

- 1 Use a range of basic historical sources to evaluate their usefulness by:**
 - 1.1 Providing a basic evaluation of the similarities and differences between at least two sources of information
 - 1.2 Providing a basic conclusion about the usefulness of at least two sources of information
 - 1.3 Taking into account content and context by applying appropriate recall of basic factual information

Outcome 2

The learner will:

- 2 Draw upon a basic factual knowledge and understanding of important historical events by:**
 - 2.1 Outlining, with some accuracy, important historical events
 - 2.2 Briefly explaining important historical events

Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Sources can be either primary or secondary and at least two must be used, although there is no recommended upper limit. Evidence can be presented in a variety of formats, including participation in group tasks, presenting information to other groups, simple digital presentations and basic written responses to questions. All of the evidence does not need to be from the one activity, but can be assembled from a variety of tasks and assessments carried out during the duration of the Course.

Evidence may be presented for individual Outcomes or gathered for the Unit or Course as a whole by combining assessment holistically in one single activity.

Exemplification of assessment will be provided in the *National Assessment Resource*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below.
