



## Chemical Changes and Structure (Higher) Unit

**SCQF:** level 6 (3 SCQF credit points)

**Unit code:** H4KH 76

### Unit outline

The general aim of this Unit is to develop skills of scientific inquiry, investigation, analytical thinking, independent working, and knowledge and understanding of chemical changes and structure. Learners will apply these skills when considering the applications of chemical changes and structure on our lives, as well as the implications on society/the environment. This can be done using a variety of approaches, including investigation and problem solving.

The Unit covers the key areas of: controlling the rate, periodicity, structure and bonding. Learners will research issues, apply scientific skills and communicate information related to their findings, which will develop skills of scientific literacy.

Learners who complete this Unit will be able to:

- 1 Apply skills of scientific inquiry and draw on knowledge and understanding of the key areas of this Unit to carry out an experiment
- 2 Draw on knowledge and understanding of the key areas of this Unit and apply scientific skills

This Unit is a mandatory Unit of the Higher Chemistry Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes*, which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in the *National Assessment Resource*.

The *Course Assessment Specification* for the Higher Chemistry Course gives further mandatory information on Course coverage for learners taking this Unit as part of the Higher Chemistry Course.

## Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence can be drawn from a variety of sources and presented in a variety of formats. Evidence may be presented for individual Outcomes or gathered for the Unit as a whole, through combining assessment holistically in a single activity. If the latter approach is used, it must be clear how the evidence covers each Outcome.

Transfer of evidence: When the Outcomes and Assessment Standards are the same for the Units of the Course, differing only by context, evidence for Outcome 1 and Assessment Standard 2.2 for one Unit in this Course can be used as evidence of the achievement of Outcome 1 and Assessment Standard 2.2 in the Nature's Chemistry and Chemistry in Society *Units* of this Course.

Presenting results in an appropriate format	One format from: table, line graph, chart, key, diagram, flow chart, summaries or extended text or other appropriate formats
Drawing a valid conclusion	Include reference to the aim
Evaluating experimental procedures	Suggest two improvements with justification
Accurate statements	At least half of the responses should be correct across the key areas for the set of questions provided.
Solving problems	One of each: <ul style="list-style-type: none"> <li>◆ make generalisation/predictions</li> <li>◆ selecting information</li> <li>◆ processing information including calculations as appropriate</li> <li>◆ analyse information</li> </ul>
