### Unit outline

The general aim of this Unit is to provide learners with the opportunity to develop talking and writing skills in the modern language, and to develop their knowledge and understanding of detailed and complex language in the contexts of society, learning, employability, and culture.

Learners who complete this Unit will be able to:

- 1 Use detailed and complex spoken language in conversations
- 2 Use detailed and complex written language

This Unit is a mandatory Unit of the Higher Modern Languages Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes*, which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given in *Unit Assessment Support*.

Evidence should be gathered in combination with other Outcomes where possible, either from this Unit or in combination with the Outcomes from the Unit *Modern Languages: Understanding Language* (Higher). Evidence may also be gathered for individual Outcomes where appropriate.
