Unit outline

The general aim of this Unit is to develop mapping skills and a basic knowledge and understanding of key aspects of landscape types and weather in the United Kingdom including Scotland.

Learners who complete this Unit will be able to:

- 1 Use mapping skills in geographical contexts in the United Kingdom
- 2 Draw on basic knowledge and understanding of landscape types and weather in the United Kingdom

This Unit is an alternative mandatory Unit of the National 3 Geography Course, an optional Unit in the Scottish Studies Award at SCQF level 3 and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes* which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work.

Recommended entry

Entry to this Unit is at the discretion of the centre. However, learners would normally be expected to have attained the skills, knowledge and understanding required by one or more of the following or equivalent qualifications and/or experience:

- ◆ National 2 Social Subjects Course or relevant component Units
- ◆ National 2 Science in the Environment Course or relevant component Units

In terms of prior learning and experience, relevant experiences and outcomes may also provide an appropriate basis for doing this Unit.

Outcomes and Assessment Standards

Outcome 1

The learner will:

1 Use mapping skills in geographical contexts in the United Kingdom by:

- 1.1 Identifying basic information from a limited range of sources of geographical information
- 1.2 Interpreting a limited range of sources of geographical information

If Units are being taken as part of a Course, then the evidence for 'mapping skills' and 'research skills' Outcomes may be presented in the context of **either** *Geography: Physical Environments* **or** *Geography: Human Environments* Units.

Outcome 2

The learner will:

2 Draw on basic knowledge and understanding of landscape types and weather in the United Kingdom by:

- 2.1 Outlining key features of one landscape type
- 2.2 Briefly describing the formation of one landscape type
- 2.3 Briefly describing possible land uses of one landscape type

Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence is required to show that the learner has met the Outcomes and Assessment Standards.

A limited range of mapping skills may be developed in this Unit such as: location; direction; scale; simple relief patterns; identification of basic landforms and physical characteristics; and identifying land use and weather conditions. A range of maps can be used in this Unit which may include Ordnance Survey maps where appropriate.

If this Unit is taken as part of a Course, research skills may be used instead of mapping skills to generate evidence of successful achievement of the Outcome.

Assessment evidence can be drawn from a variety of activities and presented in a variety of formats, including, for example, presentations, posters, brief written responses to questions, and participation in group tasks. All of the evidence does not need to be from the one activity, but can be assembled from a variety of tasks and assessments carried out during the duration of the Course.

The study of landscape types must include Scotland.

Evidence may be presented for individual Outcomes or gathered for the Unit, Units or Course as a whole by combining assessment holistically.

Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below. These must be built into the Unit where there are appropriate opportunities.
