Unit outline

The general aim of this Unit is to provide learners with the opportunity to develop reading and listening skills in the modern language, and to develop their knowledge of simple language in the contexts of society, learning, employability, and culture.

Learners who complete this Unit will be able to:

- 1 Understand simple written language
- 2 Understand simple spoken language

This Unit is a mandatory Unit of the National 3 Modern Languages Course and is also available as a free-standing Unit. Evidence Requirements for the Unit

Evidence should be gathered in combination with other Outcomes where possible, either from this Unit or in combination with the Outcomes from the Unit *Modern Languages: Using Language* (National 3). Evidence may also be gathered for individual Outcomes where appropriate.

All Assessment Standards must be achieved in each piece of evidence.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit.
