Unit outline

The general aim of this Unit is to develop skills of scientific inquiry, investigation and the ability to apply knowledge and understanding in the context of human health. Learners will apply these skills when considering the applications of human health on our lives, as well as implications on the environment/society. This can be done by using a variety of approaches, including investigation and problem solving.

The Unit covers the key areas of what is health, threats to health, and health claims. Learners will research issues, apply scientific skills and communicate information related to their findings, which will develop skills of scientific literacy.

Learners who complete this Unit will be able to:

- 1 Apply skills of scientific inquiry and draw on knowledge and understanding of the key areas of this Unit to carry out an experiment/practical investigation
- 2 Draw on knowledge and understanding of the key areas of this Unit and apply scientific skills

This Unit is a mandatory Unit of the National 3 Science Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes*, which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. Exemplification of the standards in this Unit is given *in Unit Assessment Support*.

Evidence Requirements for the Unit

The Key areas covered in this Unit are:

- ◆ **threats to health**
- ◆ **health claims**
