### Unit outline

The general aim of this Unit is to provide learners with the opportunity to develop talking and writing skills in the modern language and to develop their knowledge of straightforward language in the contexts of society, learning, employability, and culture.

- 2 Use straightforward written language

This Unit is a mandatory Unit of the National 4 Modern Languages Course and is also available as a free-standing Unit.
