Personal Finance Award (GA1Y 44)

This letter contains information relating to the above group award which I hope you find useful.

The first SQA Events, since the launch of the Personal Finance Award, were held in the SQA's offices in Dalkeith and Glasgow in January 2013. Evaluations confirmed that these Network Events were well received with delegates appreciating the input from two practitioners in particular. The practitioners spoke about delivery of the award by both the Mathematics and the Business Education Departments within schools.

Qualification Support Team (QST)

A meeting of the QST was scheduled for June 2013. Unfortunately this meeting had to be cancelled as two of the members were changing job roles/schools and would no longer be involved in the delivery of Personal Finance.

SQA would like to invite Personal Finance Award practitioners to consider participating in the work of the QST which would meet once or possibly twice a year to discuss issues relating to the Award. SQA rely on practitioners to inform us of any issues with qualifications and to assist us in ensuring content, etc is current. Senior Phase Benchmarking Tool

As you may be aware a new Senior Phase Benchmarking Tool (SPBT) is being developed to support Curriculum for Excellence and help raise overall standards and quality of attainment. It will replace the current Standard Tables and Charts (STACs) and capture a wider range of awards and qualifications. The Tool will go live in August 2014 which means that STACs are being produced for the last time this year. The Scottish Government is working with a number of partners to ensure the Tool meets the needs of all staff including teachers, school leaders, quality improvement officers and those involved in inspection.

The Tool (SPBT) is being designed to:

- **Be available to a wider group of users** in secondary schools including class teachers, those in special schools and those involved with school college partnerships
- **Support Curriculum for Excellence** by developing greater understanding of strengths and areas for improvement in the senior phase by using a wide range of evidence of performance.
- **Provide more information on educational outcomes** including post school destinations and attainment in literacy and numeracy.
- **Be one of a range of approaches** to performance evaluation and improvement. These include the Scottish Survey of Literacy and Numeracy (SSLN), Education Scotland inspection processes, local authority analyses and self-evaluation.

The Tool will recognise a wider range of qualifications at Course and Unit level, this will include SQA qualifications such as National Progression Awards and qualifications from other providers.

For a small number of qualifications, such as the **Personal Finance Award**, where SQA works in partnership with another body, we are working with the Scottish Government to ensure all relevant bodies are contacted and informed of data submission requirements for the Tool. We will work with our partners to ensure data requirements and appropriate authorised data processing are met.
