# SQA's publication scheme

The purpose of this guide is to:

- ◆ allow the public to see what information is available (and what is not available) in relation to each class of information
- ◆ state what charges may be applied
- ◆ explain how to find information easily
- ◆ provide contact details for enquiries and to get help with accessing the information
- ◆ explain how to request the information we hold

## Availability

The information referred to in this publication scheme is, wherever possible, available on our website. We offer alternative arrangements for people who do not want to, or cannot, access the information online or arrange to inspect it at our premises. For example, we can usually arrange to send information to you on paper (although there may be a charge for this).

## Exempt information

We will publish the information we hold that falls within the classes of information indicated in the tables on pages 6 to 19. If a document contains information that is exempt under Scotland's Freedom of Information laws (for example sensitive personal information or a trade secret), we will remove or redact the information before publication and explain why.

## Copyright

Where SQA holds the copyright in its published information, the information may be copied or reproduced without formal permission, provided that:

- ◆ it is copied or reproduced accurately
- ◆ it is not used in a misleading context, and
- ◆ the source of the material is identified

Where SQA does not hold the copyright in information we publish, we will make this clear.

Some material we include in our publication scheme may be the copyright of a third party. Our rights to hold and use such material do not extend to others. You must obtain authorisation from the copyright holder(s) concerned if you wish to copy or reproduce such material.

## Charges
