Unit Summary

This Unit is about monitoring the effectiveness of food and drink despatch and transport operations. It covers monitoring processes by checking that the quality of the product is maintained and making recommendations for improvements, as well as ensuring risks to health and safety in the workplace are controlled.

This Unit is for you if you work in food and drink manufacturing operations and you have responsibilities for organising the despatch and transport operations of food and drink products. You may be a team leader, line manager or supervisor.

In order to be assessed as competent you must demonstrate to your assessor that you can consistently perform to the requirements set out below. Your performance evidence must include at least one observation by your assessor.
