## **Unit outline**

The general aim of this Unit is to develop learners' skills in using electoral data. Learners will apply knowledge and understanding of the complex factors which contribute to electoral performance of political parties.

Learners who complete this Unit will be able to:

- Analyse a range of electoral data to evaluate factors which contribute to the electoral performance of UK political parties
- 2 Draw on knowledge and understanding of the complex factors that contribute to the electoral performance of UK political parties

#### **Outcomes and Assessment Standards**

#### Outcome 1

The learner will:

- 1 Analyse a range of electoral data to evaluate factors which contribute to the electoral performance of UK political parties by:
- 1.1 Interpreting and analysing at least two sources of information in order to identify significant factors in the electoral performance of political parties
- 1.2 Evaluating electoral data to explain significant factors contributing to the performance of political parties

#### Outcome 2

The learner will:

- 2 Draw on knowledge and understanding of the complex factors that contribute to the electoral performance of UK political parties by:
- 2.1 Describing, in detail, the dominant ideas within a political party
- 2.2 Explaining, in detail, the ways in which the dominant ideas contributed to electoral performance of a political party
- 2.3 Evaluating the contribution of at least two factors to a political party's electoral performance

## **Evidence Requirements for the Unit**

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence is required to show that the learner has met the Outcomes and Assessment Standards.

Assessment evidence can be drawn from a number of activities and presented in a variety of formats, including, for example, presentations, posters, brief written responses to questions and participation in group tasks. All of the evidence does not need to be from the one activity, but can be assembled from a number of tasks and assessments carried out during the duration of the Unit.

Evidence may be presented for individual Outcomes or gathered for the Unit.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

#### Assessment standard thresholds

If a candidate successfully meets the requirements of the specified number of Assessment Standards they will be judged to have passed the Unit overall and no further re-assessment will be required.

The specific requirements for this Unit is as follows:

- Both Assessment Standards must be achieved for Outcome 1.
- ♦ 2 out of 3 Assessment Standards must be achieved for Outcome 2.

It should be noted that there will still be the requirement for candidates to be given the opportunity to meet all Assessment Standards. The above threshold has been put in place to reduce the volume of re-assessment where that is required.

# Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below.
