Unit outline

The general aim of this Unit is to develop learners' skills in comparing different political systems. Learners will apply knowledge and understanding of political processes and constitutional arrangements.

Learners who complete this Unit will be able to:

- 1 Use a range of sources of information to compare different political systems
- 2 Draw on knowledge and understanding of different political systems

Outcomes and Assessment Standards

Outcome 1

The learner will:

- 1 Use a range of sources of information to compare different political systems by:
- 1.1 Using at least two sources of information to identify two comparable features of two political systems
- 1.2 Synthesising information which compares an aspect of two political systems
- 1.3 Comparing the extent of difference or similarity between an aspect of two political systems

Outcome 2

The learner will:

- 2 Draw on knowledge and understanding of different political systems by:
- 2.1 Describing in detail and explaining in detail an aspect of two political systems
- 2.2 Analysing a complex issue in two political systems

Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence is required to show that the learner has met the Outcomes and Assessment Standards.

Assessment evidence can be drawn from a number of activities and presented in a variety of formats, including, for example, presentations, posters, brief written responses to questions and participation in group tasks. All of the evidence does not need to be from the one activity, but can be assembled from a number of tasks and assessments carried out during the duration of the Unit.

Evidence may be presented for individual Outcomes or gathered for the Unit.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

Assessment standard thresholds

If a candidate successfully meets the requirements of the specified number of Assessment Standards they will be judged to have passed the Unit overall and no further re-assessment will be required.

The specific requirements for this Unit is as follows:

- ♦ All Assessment Standards must be achieved for Outcome 1.
- ♦ 1 out of 2 Assessment Standards must be achieved for Outcome 2.

It should be noted that there will still be the requirement for candidates to be given the opportunity to meet all Assessment Standards. The above threshold has been put in place to reduce the volume of re-assessment where that is required.

Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below.
