## **Unit outline**

The general aim of this Unit is to develop learners' skills in evaluating political ideologies. Learners will apply knowledge and understanding of political concepts.

- 1 Use a range of sources of information to evaluate different political ideologies or political concepts
- 2 Draw on theoretical and conceptual knowledge and understanding of political ideologies or political concepts

#### Outcome 2

The learner will:

- 2 Draw on theoretical and conceptual knowledge and understanding of political ideologies or political concepts by:
- 2.1 Describing in detail and explaining in detail two political ideologies or two political concepts
- 2.2 Analysing two political ideologies or two political concepts

# **Evidence requirements for the Unit**

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence is required to show that the learner has met the Outcomes and Assessment Standards.

Assessment evidence can be drawn from a number of activities and presented in a variety of formats, including, for example, presentations, posters, brief written responses to questions and participation in group tasks. All of the evidence does not need to be from the one activity, but can be assembled from a number of tasks and assessments carried out during the duration of the Unit.

Evidence may be presented for individual Outcomes or gathered for the Unit.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

# Assessment standard thresholds

If a candidate successfully meets the requirements of the specified number of Assessment Standards they will be judged to have passed the Unit overall and no further re-assessment will be required.

The specific requirements for this Unit is as follows:

- ♦ All Assessment Standards must be achieved for Outcome 1.
- ♦ 1 out of 2 Assessment Standards must be achieved for Outcome 2.

It should be noted that there will still be the requirement for candidates to be given the opportunity to meet all Assessment Standards. The above threshold has been put in place to reduce the volume of re-assessment where that is required.

It is expected that learners will develop broad, generic skills through this Unit.
