Unit outline

The general aim of this Unit is to introduce learners to issues concerning their environment.

Learners who complete this Unit will be able to:

- 1 identify some of the main causes and effects of environmental damage
- 2 identify actions that could be taken to reduce environmental damage
- 3 participate in an activity aimed at reducing environmental damage

This Unit is an optional Unit of the Personal Development Award (SCQF level 2) and is also available as a free-standing Unit. The *Unit Specification* should be read in conjunction with the *Unit Support Notes*, which provides advice and guidance on delivery, assessment approaches, and development of skills for learning, skills for life, and skills for work. Outcomes and assessment standards

Outcome 1

The learner will:

- 1 Identify some of the main causes and effects of environmental damage by:
- 1.1 identifying different types of environmental damage
- 1.2 identifying the effects of these types of environmental damage

Outcome 2

The learner will:

- 2 Identify actions that could be taken to reduce environmental damage by:
- 2.1 identifying a variety of actions that could be taken by society to reduce environmental damage
- 2.2 identifying own actions that could be taken to reduce environmental damage

Outcome 3

The learner will:

- 3 Participate in an activity aimed at reducing environmental damage by:
- 3.1 agreeing own role in an activity that will help reduce environmental damage
- 3.2 carrying out own role in the activity as agreed
- 3.3 providing information to another person during the activity
- 3.4 seeking information from another person during the activity

Evidence requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

It is expected that learners will receive support to achieve the outcomes of this Unit.

For Outcome 1, environmental damage can include: pollution (eg air/light/noise/water); waste disposal (eg landfill/plastics); overfishing; deforestation.

For Outcome 2, society can include: the centre, the local community, national campaigns, and global campaigns. Personal actions can include: activities within the home, activities within the centre, participation in national campaigns, and participation in global campaigns.

For Outcome 3, the activity can be: individual-based/group-based/working with others.

Evidence for Outcomes 1, 2 and 3

Evidence for this Unit could include logs, checklists, short written responses, completed templates, recorded oral responses, photographic evidence, video evidence, or their equivalent.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

Development of skills for learning, skills for life, and skills for work

It is expected that learners will develop broad, generic skills through this Unit.
