



## Working with Textiles (Alternative Context) National 2

## **SCQF:** level 2 (6 SCQF credit points)

## Unit code: HK4J 72

This Unit should only be used where a learner has already achieved the original Unit, which carries the same title but without the words "Alternative Context". There should be at least one year between the delivery of the original Unit and the delivery of the "Alternative Context" version.

For this Unit, centres can use one of the Unit Assessment Support Packs provided with the original Unit, but adjust it to reflect the alternative context in which the Unit is delivered. The alternative context could relate to the delivery setting, the maturity of the learner or the activities the learner is asked to complete.

# **Unit outline**

The general aim of this Unit is to allow learners to develop the skills and knowledge which support fashion and textile-related activity such as weaving, collage, knitting, crochet, and items for drama and dance.

Learners who complete this Unit will be able to:

- 1 Demonstrate skills and knowledge in working creatively with textiles
- 2 Produce a creative textile item

This Unit is an optional Unit of the National 2 Creative Arts Course and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes,* which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work. - 2.1 Choosing a creative item
- 2.2 Choosing materials and equipment essential to making the item
- 2.3 Using selected materials and equipment appropriately
- 2.4 Following safe work practices for using the equipment correctly
- 2.5 Completing the item

### **Evidence Requirements for the Unit**

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence may be presented for individual Outcomes or it may be gathered for the Unit as a whole through integrating assessment for both Outcomes. If the latter approach is used, it must be clear how the evidence covers each Outcome.

For Outcomes 1 and 2, evidence is required which demonstrates the learner selecting and using appropriate skills, materials and equipment to produce a creative textile item. Evidence which demonstrates the learner appropriately preparing materials for the creative textile item is also required. At least two different forms of materials should be selected and prepared.

Evidence should capture the processes followed by the learner while developing their ideas and using their skills, techniques and materials as well as the creative textile work produced.

Evidence which demonstrates the learner using equipment safely and correctly is required.

Only one creative textile item is required to provide the evidence.

It is expected that learners will receive support to achieve the Outcomes of this Unit.

Evidence can be presented in a variety of formats, such as written, oral, or pictorial, and may be gathered using the learner's usual means of communication.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit SupportNotes*.

## Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below. These must be built into the Unit where there are appropriate opportunities.
