Unit outline

The general aim of this Unit is to provide learners with the opportunity to develop the skills needed to plan and create Scottish media content, and to evaluate production processes. Learners develop detailed knowledge and understanding of the key aspects of media literacy central to creating media content.

Learners who complete this Unit will be able to:

- 1 Create media content

Outcome 1

The learner will:

1 Create media content by:

- 1.1 Planning and developing ideas in response to a negotiated brief
- 1.2 Applying production skills appropriate to the media content and context
- 1.3 Evaluating the production process
- 1.4 Applying detailed knowledge and understanding of relevant key aspects of media literacy

Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence should be gathered in combination with other Outcomes where possible, in combination with the Outcome from the Unit *Analysing Media Content* (SCQF level 5). Evidence may also be gathered for individual Outcomes where appropriate.

For this Unit, learners will be required to create media content based on a Scottish stimulus or on a Scottish theme. Learners will be required to provide evidence of each of the following in response to a negotiated brief:

- ◆ planning and research skills
- ◆ production skills (can include pre-production, production and post-production)
- ◆ evaluation skills
- ◆ knowledge of key aspects of media literacy central to creating media knowledge

Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below. These must be built into the Unit where there are appropriate opportunities.

4 Employability, enterprise and citizenship
