

## Modern Studies: Social Issues in the United Kingdom with a Scottish Context

### Unit outline

The general aim of this Unit is to develop skills of using sources of information to make and justify decisions and develop a detailed knowledge and understanding of social issues in Scotland drawn from **either** a study of social inequality **or** crime and the law.

Learners who complete this Unit will be able to:

- 1 Use a range of sources of information to make and justify decisions about social issues in the United Kingdom, focusing on either social inequality or crime and the law
- 2 Draw on a detailed knowledge and understanding of social issues in the United Kingdom, focusing on either social inequality or crime and the law

This Unit is an optional Unit in the Scottish Studies Award at SCQF level 5 and is also available as a free-standing Unit. The Unit Specification should be read in conjunction with the *Unit Support Notes* which provide advice and guidance on delivery, assessment approaches and development of skills for learning, skills for life and skills for work.

  - 2.2 Giving detailed explanations relating to a social issue in the United Kingdom

## Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence is required to show that the learner has met the Outcomes and Assessment Standards.

The sources of information used may be written, numerical, graphical, pictorial, audio-visual or oral.

Assessment evidence can be drawn from a variety of activities and presented in a variety of formats, including, for example, presentations, posters, brief written responses to questions and participation in group tasks. All of the evidence does not need to be from the one activity, but can be assembled from a variety of tasks and assessments carried out during the duration of the Course.

Evidence may be presented for individual Outcomes or gathered for the Unit, Units or Course as a whole by combining assessment holistically.

If the focus of the learning in this Unit is on social inequality, social inequality must be studied from the perspective of at least one of the following: race, gender, social class, age, disability or other recognised cause of inequality and must have a Scottish context
