Coursework and/ or Question Paper revisions

The practical activity will continue to be assessed across three stages. Stage 1 will be completed in centres and submitted to SQA for external marking. Stages 2 and 3 will be internally marked and subject to visiting verification.

A new question paper will be introduced that will be worth around 30 marks, it will assess the knowledge and understanding that is currently assessed in the units and be externally assessed by SQA.

Scaling will be applied to achieve the following weightings: practical activity 75% and question paper 25%.

Equality & inclusion issues

No changes have been made to the aims, rationale or content of the course. Only the Course assessment has changed as outlined above. This means that the original equality review carried out and attached remains valid and fit for purpose. It should be noted however, that the Units, which were a feature of the original ERF, have now been removed.

Introduction of a question paper

The introduction of a question paper in subjects where practical Course work had previously comprised 100% of the external assessment could have potential adverse impacts for some disabled candidates, for example the necessary constraints of the controlled conditions of an external examination may place them at a substantial disadvantage where previously no question paper existed and less controlled conditions often pertained. For some other candidates, who may have chosen a practical subject because of their specific disability in reading and/or writing, may be disadvantaged by the introduction of a written question paper. We have not identified anything in the introduction of a new question paper that would have a negative impact on students because of any of the other protected characteristics

Actions that will mitigate any adverse impact outlined above

While it is not possible to exempt disabled learners from the external QP at National 5 where this is an integral assessment, the provision of appropriate adapted equipment, assessment arrangements such as the use of a practical assistant and other supportive practices will mitigate the adverse impact for many candidates. In addition, SQA will ensure that there is an appropriate review of the language used in the question paper to ensure it is as accessible as possible. SQA will also continue to ensure that individual requests for reasonable adjustments are considered where appropriate.

Summary of Conclusion and recommendation

The Outcomes of the Units and the Course assessments relate to the aims and purposes of the Course and have been developed to be as inclusive and accessible as possible.
