1 Introduction

This document was previously known as the arrangements document. The purpose of this document is to:

- assist centres to implement, deliver and manage the qualification
- provide a guide for new staff involved in offering the qualification
- inform course managers teaching staff, assessors, learners, employers and HEIs of the aims and purpose of the qualification
- provide details of the range of learners the qualification is suitable for and progression opportunities

The suite of SCQF level 6 awards detailed in this document has been specifically designed to address the requirements for suitably trained and qualified chainsaw operators. SQA has worked in partnership with industry body the Highways and Construction Training Association (HCTA) to create this suite of qualifications which will allow successful learners to demonstrate to employers and others that they can safely and effectively operate a chainsaw or related equipment under the conditions of the specific qualification they have achieved.

The qualifications have been designed for occasional chainsaw users including highways maintenance workers and maintenance contractors. A range of group awards have been produced to ensure that the different contexts that may require chainsaw use are covered and there are also awards to cover the use of related equipment and machinery, such as powered pole saws, wood chippers and Mobile Elevated Working Platforms (MEWPs).

Those learners who undertake an award or awards as part of the HCTA Chainsaw Operators Registration Scheme (CORS) will be eligible for a CORS card which will detail the areas they are qualified for and the currency of the qualifications, either 3 or 5 years depending on frequency of use. The titles of the group awards have been selected to represent the specific competencies they cover and to correspond with the existing HCTA Chainsaw Operators Registration Scheme. Each award is at SCQF level 6 and they can be combined and built upon to reflect the range of activities the learner is required to carry out. While these qualifications have been designed with the occasional user working in a highways context in mind they may also be a useful starting point for those wishing to pursue a career within Forestry, Arboriculture, Silviculture or Amenity Horticulture/Landscaping.

The design principles for the award gualification type state:

- An award and its component unit(s) will be allocated to a level appropriate to their ٠ position in the SCQF
- Awards can be set at SCQF levels 1–12
- Awards have no restriction on the value of SCQF credit points
- Awards may have:
 - Mandatory units only
 - Mandatory and optional units
 - Optional units only
- Where the award comprises of a single unit, the level of the award must correspond with the level of the unit. Where the award is comprised of more than one unit, more than half the units must be at the level of the award
- The minimum number of units that an award can contain is one
- Awards can be any combination of HN Units, SVQ Units, National (Workplace), or National Units
- There is no limit to the number of units an award can contain
- The units can be of any credit value

Each of the qualifications detailed above consists of one or more mandatory units, each unit consisting of 3 SCQF credit points at SCQF level 6. The overall SCQF level of each award is SCQF level 6. Each award fully meets the requirements of the design principles.

Units achieved as part of one group award can contribute to other group awards, for example a learner who achieves GP5A 46 Chainsaw Felling Small Trees (HH4N 46, HH4P 46 and HH4R 46) would only require to complete unit HH53 46 Clear Multiple Fallen or Windblown Trees to also achieve GP5E 46 Clear Multiple Windblown Trees. Please note learners undertaking these awards as part of the HCTA CORS scheme would have to achieve any additional units within the period of currency of the awards they already hold (either 3 or 5 years).

Aims of the qualifications 3

The principle aim of this suite of awards is to allow learners to demonstrate that they are suitably trained and gualified in the context of the award or awards they undertake.

3.1 General aims of the gualifications

- To enhance the learner's employability skills
- To allow the learner to demonstrate competence in specific vocational skills
- To create a structure to allow learners to build upon and progress their skills
- To demonstrate the learner's ability to work safely
- To provide a progression route to learners who wish to further develop their skills

3.2 Specific aims of the qualifications

- (a) To develop the ability to effectively assess risks and adjust working processes accordingly
- (b) To develop the ability to evaluate a site prior to commencing operations
- (c) To develop an awareness of the individuals competence to carry out specific tasks
- (d) To develop the skills required to safely maintain machinery and equipment
- (e) To develop the knowledge and skills required to minimise environmental impacts
- (f) To develop the knowledge and skills required to safely deal with timber under tension and compression
- (g) To develop the knowledge required to select appropriate equipment for a specific operation
- (h) To develop the knowledge and skills to safely operate a range of tools and equipment

4 Recommended entry to the qualifications

Entry to this qualification is at the discretion of the centre. The following information on prior knowledge, skills, experience or qualifications that provide suitable preparation for this qualification has been provided by the Qualification Design Team as guidance only.

The group awards have been designed to ensure that all learners have received or are in the process of receiving the appropriate training for the specific award they are undertaking.

Any award that requires either the use and/or maintenance of a chainsaw contains the relevant units (Chainsaw Maintenance and Crosscutting Lying Timber).

The awards in Winch Operations, Powered Pole Saw Operations and Wood Chipper Operations have no specific entry requirements.

Mobile Elevated Working Platform Limbing Operations requires that the learners are suitably trained and qualified to operate a Mobile Elevated Working Platform (MEWP). The award is designed to cover the safe use of a chainsaw from a MEWP but does not cover the use of the MEWP itself, this must be demonstrated by a suitable gualification, prior to undertaking the award.

Suitable alternative qualifications may be considered however the centre must ensure that the alternative qualification is current and meets or exceeds the requirements of the relevant SQA provision.

There is no official minimum age for a learner to undertake these awards; however the following guidance from the health and safety executive must be taken in to account:

Young workers

A young person is anyone under 18 and a child is anyone who has not yet reached the official minimum school leaving age which may be just before, on, or just after their 16th birthday.

Employers are responsible for ensuring a young person is not exposed to risk due to lack of experience, being unaware of existing or potential risks or a lack of maturity.

You must let the parents/guardians of any child know the key findings of the risk assessment and the control measures put in place before the child starts work or work experience.

Before deciding whether you can employ a young person, you must consider:

- the layout of the workplace ٠
- any physical, biological and chemical agents they may be exposed to ٠
- the work equipment they will use
- how work activities and processes are organised
- the need for health and safety training

In health and safety law, students and trainees on work experience are employees. Once you've assessed the risks to them, you must provide them with the same health, safety and welfare protection as other employees.'

5 Additional benefits of the qualification in meeting employer needs

This qualification was designed to meet a specific purpose and what follows are details on how that purpose has been met through mapping of the units to the aims of the gualification. Through meeting the aims, additional value has been achieved by linking the unit standards with those defined in National Occupational Standards and/or trade/professional body requirements. In addition, significant opportunities exist for learners to develop the more generic skill, known as Core Skills through doing this gualification.

Guidance on approaches to delivery and 6 assessment

The primary purpose of these awards is to allow the learner to demonstrate they are suitably trained and gualified to safely carry out the activities covered by the award. They provide a flexible set of qualifications that allow recognition of a range of levels of responsibility including the size and/or number of trees to be felled/cleared and the range of equipment that can safely be operated. Each award will allow the successful learner to apply for the equivalent license from the Highways and Construction Training Association (HCTA) through their Chainsaw Operators Registration Scheme (CORS).

6.1 Sequencing/integration of units

The delivery sequence of units within a particular award will to some extent be dictated by environmental and site conditions which will determine if and when it is safe to carry out certain activities. However, in order to comply with legal requirements and to ensure the health and safety of the learner and others units must be delivered in an appropriate sequence. For example in the Chainsaw Felling Large Trees award, units Maintain a Chainsaw, Clear Lying Timber and Felling Small Trees must be undertaken before unit Felling Large Trees to ensure the learner is appropriately trained to undertake the requirements of the latter unit.

There may be opportunities, where it is safe to do so, to integrate some aspects of the delivery and assessment of various units. For example there may be a naturally occurring opportunity in Outcome 2 'Undertake routine chainsaw maintenance' of unit Maintain a Chainsaw to integrate with unit Clear Lying Timber Outcome 4 Performance Criteria (i) 'Ensure chainsaw and other equipment is left in a well maintained condition when operations are complete'.

Recognition of prior learning 6.2

SQA recognises that learners gain knowledge and skills acquired through formal, non-formal and informal learning contexts.

In some instances, a full group award may be achieved through the recognition of prior learning. However, it is unlikely that a learner would have the appropriate prior learning and experience to meet all the requirements of a full group award.

The recognition of prior learning may **not** be used as a method of assessing in the following types of units and assessments:

- Course and/or external assessments ٠
- Other integrative assessment units (which may or not be graded)
- Certain types of assessment instruments where the standard may be compromised by not using the same assessment method outlined in the unit

- Where otherwise specified in an assessment strategy

These gualifications have been specifically designed to provide the learner with the knowledge and skills required for the Chainsaw Operators Registration Scheme (CORS) administered by the Highways and Construction Training Association (HCTA). Successful completion of a qualification will allow the learner to apply for registration for the relevant area on the CORS scheme, for either 3 or 5 years. 6.3 **Opportunities for e-assessment**

The units contained within these awards are all of a highly practical nature and as such do not lend themselves to e-assessment. There may be limited opportunities for e-assessment such as Outcome 1 of unit Maintain a Chainsaw where e-assessment could be used for the identification exercise, however for health and safety reasons all practical assessments must take place under the direct supervision of a suitably qualified assessor. An e-portfolio could be used to organise and retain the learner's evidence across units and group awards.

Carry Out Limbing Operations from a Mobile Elevated Work Platform (MEWP)	A working MEWP, chainsaw and PPE to carry out operations is to be available. The site must contain suitable trees to work on to enable learners to demonstrate the performances given. Equipment and fall arrest equipment must have a recent certificate of thorough examination/inspection available.

6.5 Use of simulation

Given the highly practical nature of these awards it is crucial that learners are given the opportunity to develop their knowledge and skills in a realistic working environment to learn how to adjust to a varied environment, conditions and restrictions. There may be circumstances where it is not possible, safe or practical to make use of naturally occurring opportunities to develop evidence, for example where multiple hung-up trees are required. In such circumstances a degree of simulation would be acceptable; however every effort should be made to ensure conditions mirror likely real working conditions as far as possible.

The following extract from the Lantra Assessment Strategy (December 2015) provides additional guidance:

- All simulations must be planned, developed and documented by the centre in a way that ٠ ensures the simulation correctly reflects what the standard seeks to assess
- The physical environment for the simulation must be as realistic as possible, reflecting industry working practices and drawing on real resources that would be used in the industry
- The simulation must also reflect the same pressures and time constraints that might apply in the workplace
- Simulations can only be used to supplement real work activities and should not be the only source of evidence used to indicate competence

Where there is any doubt around realistic working environments or the use of simulation advice should be sought from an SQA external verifier.

8 **Glossary of terms**

CORS: Chainsaw Operators Registration Scheme

Embedded Core Skills: is where the assessment evidence for the unit also includes full evidence for complete Core Skill or Core Skill components. A learner successfully completing the unit will be automatically certificated for the Core Skill. (This depends on the unit having been successfully audited and validated for Core Skills certification)

Finish date: The end of a group award's lapsing period is known as the finish date. After the finish date, the group award will no longer be live and the following applies:

- learners may not be entered for the group award ٠
- the group award will continue to exist only as an archive record on the Awards Processing System (APS)

HCTA: Highways and Construction Training Association

Lapsing date: When a group award is entered into its lapsing period, the following will apply:

- the group award will be deleted from the relevant catalogue
- the group award specification will remain until the gualification reaches its finish date at which point it will be removed from SQA's website and archived
- no new centres may be approved to offer the group award

SQA credit value: The credit value allocated to a unit gives an indication of the contribution the unit makes to an SQA group award. An SQA credit value of 1 given to an SQA unit represents approximately 40 hours of programmed learning, teaching and assessment.

SCQF: The Scottish Credit and Qualification Framework (SCQF) provides the national common framework for describing all relevant programmes of learning and gualifications in Scotland. SCQF credit points: SCQF credit points provide a means of describing and comparing the amount of learning that is required to complete a gualification at a given level of the framework. SCQF levels: The level a qualification is assigned within the framework is an indication of how hard it is to achieve. The SCQF covers 12 levels of learning. HNCs and HNDs are available at SCQF levels 7 and 8 respectively. Higher National Units will normally be at levels 6-9 and Graded Units will be at level 7 and 8. National Qualification Group Awards are available at SCQF levels 2-6 and will normally be made up of National Units which are available from SCQF levels 2-7.

General information for learners 9

This section will help you decide whether this is the qualification for you by explaining what the gualification is about, what you should know or be able to do before you start, what you will need to do during the qualification and opportunities for further learning and employment.

If you are a chainsaw operator or wish to work in a sector that requires you to use a chainsaw one or more of these qualifications may be suitable for you.

Each qualification has been designed to allow you to demonstrate that you are suitably trained and qualified to undertake a specific operation or operations. The areas covered are as follows:

- Chainsaw Maintenance and Use ٠
- **Chainsaw Felling Small Trees** ٠
- Chainsaw Felling Large Trees ٠
- Clear Individual Windblown Trees
- Clear Multiple Windblown Trees
- Hand Winch Operations ٠
- **Powered Pole Saw Operations**
- Wood Chipper Operations
- Mobile Elevated Working Platform (MEWP) Limbing Operations

These are practical qualifications, in order to achieve them you will be required to demonstrate that you can safely and effectively demonstrate the required skills in a real working environment. In addition to the practical skills you will also be assessed on the knowledge that underpins these skills. For example you will be required to identify and state the purpose of a range of chainsaw components in addition to being able to remove, clean, maintain and replace them.

The various qualifications all consist of one or more units, these units and qualification can be taken in various combinations depending on the type of work you are required to undertake and the types of equipment you are required to use. Your centre will be able to advise you on the most suitable qualifications to undertake depending on the type of work you will be involved in.

These qualifications would be suitable for you if you are working or seeking work as:

- Term maintenance contractors ٠
- Local authority grounds maintenance staff
- Emergency workers on highways

While many of the skills covered by these qualifications will be shared with those from the forestry and arboriculture sector they have not been designed for those sectors, as they do not have a particular focus on the end of use of the trees/timber.

On successful completion of an award you will be able to apply for the corresponding recognition from the Chainsaw Operators Registration Scheme (CORS), which will allow you to demonstrate your competence to employers and others.
