Unit outline

The general aim of this Unit is to develop the learner's skills in explaining and expressing views on the usefulness of sources of evidence in comparing and contrasting the classical Greek and modern worlds. Learners will develop detailed factual and theoretical knowledge and understanding of religious, political, social, moral or cultural aspects of life in classical Greece.

Learners who complete this Unit will be able to:

- 1 Express reasoned views about the usefulness of sources of evidence in comparing and contrasting the classical Greek and modern worlds
- 2 Apply knowledge and understanding of life in classical Greece

Outcomes and Assessment Standards

Outcome 1

The learner will:

- 1 Express reasoned views about the usefulness of sources of evidence in comparing and contrasting the classical Greek and modern worlds, by:
- 1.1 Explaining the content of a source of evidence about life in classical Greece, in detailed terms
- 1.2 Explaining a similarity and a difference that the source reveals between life in the classical Greek and modern worlds, in detailed factual and theoretical terms
- 1.3 Expressing a reasoned conclusion on the value of a source of evidence in providing information about life in classical Greece, in detailed terms and with reference to supporting evidence

Outcome 2

The learner will:

- 2 Apply knowledge and understanding of life in classical Greece, by:
- 2.1 Explaining a key aspect of religious, political, social, moral or cultural life in classical Greece society, in detailed factual and theoretical terms

Evidence Requirements for the Unit

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence is required to show that the learner has met the Outcomes and Assessment Standards.

The sources used may be physical artefacts, written, numerical, graphical, audio/visual, pictorial or oral.

Assessment evidence can be drawn from a variety of activities and presented in a variety of format including, for example, presentations, posters, brief written responses to questions, or participation in group tasks. All of the evidence does not need to come from the one activity, but can be assembled from a variety of tasks and assessments carried out during the duration of the Unit.

Evidence may be presented for individual Outcomes, or gathered for the Unit.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

Assessment standard thresholds

If a candidate successfully meets the requirements of the specified number of Assessment Standards they will be judged to have passed the Unit overall and no further re-assessment will be required.

The specific requirements for this Unit is as follows:

- ♦ 2 out of 3 Assessment Standards must be achieved for Outcome 1.
- The Assessment Standard must be achieved for Outcome 2.

It should be noted that there will still be the requirement for candidates to be given the opportunity to meet all Assessment Standards. The above threshold has been put in place to reduce the volume of re-assessment where that is required.

Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below. These must be built into the Unit where there are appropriate opportunities.
