



## Information and Communications Technology: Capturing Digital Images (Alternative Context) National 2

# **SCQF:** level 2 (6 SCQF credit points)

# Unit code: HK1T 72

This Unit should only be used where a learner has already achieved the original Unit, which carries the same title but without the words "Alternative Context". There should be at least one year between the delivery of the original Unit and the delivery of the "Alternative Context" version.

For this Unit, centres can use one of the Unit Assessment Support Packs provided with the original Unit, but adjust it to reflect the alternative context in which the Unit is delivered. The alternative context could relate to the delivery setting, the maturity of the learner or the activities the learner is asked to complete.

# Unit outline

The general aim of this Unit is to provide opportunities for learners to explore digital images and devices and create a portfolio of their own digital images using a digital device.

Learners who complete this Unit will be able to:

- 1 Explore digital images.
- 2 Create a portfolio of digital images.

Exemplification of the standards in this Unit is given in *Unit Assessment Support*.

This Unit is a free-standing Unit and it **does not** contribute to the National 2 Information and Communications Technology Course. It offers a broadening option for any candidate working at National 2 level.

## **Outcomes and Assessment Standards**

## Outcome 1

The learner will:

#### 1 Explore digital images by:

- 1.1 Identifying the main features and/or functions of a digital device which captures images
- 1.2 Identifying basic photographic techniques used in given digital images
- 1.3 Communicating a personal response to given digital images

## Outcome 2

The learner will:

#### 2 Create a portfolio of digital images by:

- 2.1 Choosing an appropriate topic for images
- 2.2 Capturing images of chosen topic
- 2.3 Displaying images in an appropriate format
- 2.4 Identifying strengths and opportunities for improvement in their own work

## **Evidence Requirements for the Unit**

Assessors should use their professional judgement, subject knowledge and experience, and understanding of their learners, to determine the most appropriate ways to generate evidence and the conditions and contexts in which they are used.

Evidence may be presented for individual Outcomes or it may be gathered for the Unit as a whole through integrating assessment for both Outcomes. If the latter approach is used, it must be clear how the evidence covers each Outcome.

For Outcome 1, evidence is required which demonstrates that the learner has identified the main features and/or functions of a digital device which captures images. Evidence is also required that the learner has identified basic photographic techniques used in given digital images, and that the learner has communicated a personal response to given digital images.

For Outcome 2, evidence is required which demonstrates the learner's use of a digital device to capture images of their chosen subject(s)/topic(s). Evidence is also required to demonstrate the learner's selection and use of an appropriate format to display the captured images. Evidence is required which demonstrates the learner's identification of at least one strength and at least one possible improvement for at least two of their captured images.

The images only need to be shown once to provide the required evidence. The captured images could be shown to the teacher/lecturer, shared with peers, or shared

with others (eg as part of an event within the centre) as appropriate to provide the required evidence.

It is expected that learners will receive support to achieve the Outcomes of this Unit.

For this Unit, evidence could include audio and/or audio-visual files recorded on CD and/or DVD, printed materials, observation checklists, logs, recorded oral responses, photographic evidence, video evidence, or their equivalent. Assessors should be confident that there is sufficient evidence to support their judgement that the Assessment Standards have been met. Evidence may be gathered using the learner's usual means of communication.

Exemplification of assessment is provided in *Unit Assessment Support*. Advice and guidance on possible approaches to assessment is provided in the *Unit Support Notes*.

# Development of skills for learning, skills for life and skills for work

It is expected that learners will develop broad, generic skills through this Unit. The skills that learners will be expected to improve on and develop through the Unit are based on SQA's *Skills Framework: Skills for Learning, Skills for Life and Skills for Work* and drawn from the main skills areas listed below.
