Case Study 1

Canine Campus Pet Rescue and Food Bank is an animal charity and rehoming service based in Glasgow. A dedicated team of employees and volunteers promote animal welfare and transform the lives of unwanted and abandoned animals. The food bank provides vital donations of pet food, treats and bedding to help people struggling to look after their pets.

Employees and volunteers are trained to handle all kinds of animals. They also conduct thorough assessments to identify the needs of each rescued animal. Volunteers are a vital part of the charity helping with day-to-day tasks of caring for animals. They also help with paperwork, adoption follow-ups and fundraising. The charity specialises in the rehabilitation of dogs with health and behavioural issues that most other pet rescue charities would turn away.

Both animals and families are fully assessed before adoption to ensure a good match. Once a successful match is made, the family pays an adoption fee. If circumstances change and adopting [Braille page 3] families can no longer look after the animal, it must be returned to the charity rather than being sold on.
