

# Level 6 End Point Assessment for Licensed Conveyancer (603/3886/6) End Point Assessment Specification

## **General information**

This specification provides information for apprentices, employers, Trailblazer groups, training providers, and assessors involved in the Level 6 End Point Assessment (EPA) for Licensed Conveyancer.

The Level 6 End Point Assessment for Licensed Conveyancer has been developed by SQA to meet the requirements set out in the *Licensed Conveyancer Apprenticeship Approach to Assessment*, as developed by industry employers within the Conveyancing Trailblazer Group.

On successful achievement of the EPA, each apprentice will receive notification of their result from SQA. The EPA must be achieved to receive the apprenticeship, which will be certificated by the Education and Skills Funding Agency.

## The EPA's objective

This is an assessment of existing knowledge and skills. It is a holistic assessment based on the application of what the apprentice has learned during the apprenticeship.

The EPA should assess the apprentice's:

- understanding of the factual and theoretical knowledge needed to critically analyse, interpret and evaluate complex information pertinent to a conveyancing transaction in order to satisfactorily conclude non-standard freehold and leasehold conveyancing matters and if relevant to the business commercial and agricultural matters; and should assess their ability to address ambiguous detail encountered in the course of conducting conveyancing matters
- ability to interpret relevant principles, and interacting factors associated with conducting non-standard conveyancing matters on a range of titles; including freehold, leasehold, and if pertinent to the business commercial and agricultural titles
- breadth of critical knowledge and understanding of types of information that are relevant to establish remedies for non-standard conveyancing matters on freehold and leasehold and if relevant to the business commercial and agricultural matters; and that they understand when it is appropriate to escalate a matter when it becomes beyond their professional competence to deliver the legal service that is being provided

# Qualifications, prior knowledge, skills and understanding and other requirements

The following requirements are mandatory.

The apprentice must be deemed to be ready for end point assessment by an employer and/or training provider<sup>1</sup>. This includes:

- Successful completion of a Level 4 CLC professional qualification. The qualification developed specifically for the Level 4 Standard is the Level 4 Diploma in Conveyancing Law and Practice Diploma. The Level 4 Diploma contains the following units:
  - 1 The English Legal System
  - 2 Law of Contract
  - 3 Land Law
  - 4 Standard Conveyancing Transactions
  - 5 Understanding Accounting Procedures for Conveyancing
- Successful completion of a Level 6 CLC professional qualification. The qualification developed specifically for the Level 6 Standard is the Level 6 Diploma in Conveyancing Law and Practice. The Level 6 Diploma contains the following units:
  - 1 Landlord and Tenant
  - 2 Conveyancing Law and Practice
  - 3 Managing Client and Office Accounts (Conveyancing)
- The Employer Statement of Competency
- English and Maths Functional Skills at Level 2

#### Methods of assessment

The EPA has two components:

- Part 1 is a scenario test that is taken online. It lasts two hours and consists of two scenarios. There are two questions for each scenario.
- Part 2 is a showcase and professional discussion. The evidence for the showcase must be collected during the last six months of the apprenticeship. The professional discussion is with an independent assessor and lasts one hour.

#### EPA conditions and requirements for attainment

The EPA will take place in the last six months of the apprenticeship.

Part 1 must be achieved before Part 2 is submitted.

Apprentices must pass both parts to achieve the EPA award.

Apprentices will be given two opportunities in total (initial assessment and a re-sit) to achieve Part 1 and two opportunities in total (initial assessment and a re-sit) to achieve Part 2.

The EPA and its components are assessed on a pass/fail basis. There is no grading in the Level 6 End Point Assessment for Licensed Conveyancer.

#### Level and learning time

This EPA is designed for apprentices who have achieved Level 6 qualifications (see 'Qualifications, prior knowledge, skills and understanding and other requirements' above) and the level is consistent with the *Licensed Conveyancer Apprenticeship Approach to Assessment: Summary*. There is a link to this document below and from <u>SQA's EPA web page</u>.

In accordance with the *Licensed Conveyancer Apprenticeship Approach to Assessment: Summary*, the times for assessment are as follows:

- Part 1 The scenario test is two hours.
- Part 2 The showcase has no set time for development.
- Part 2 The professional discussion is one hour.
