Unit outline

This 'Eco-awareness' Unit at SCQF level 1 is part of the Personal Achievement Award suite of Units.

The general aim of this Unit is to provide opportunities for the learner to develop eco-awareness. Activities to develop eco-awareness could include: the processes and benefits of recycling, ways of saving energy in the home and/or wider community, or taking part in an eco-awareness campaign.

Learners who complete this Unit will be able to:

- 1 Prepare for an activity involving eco-awareness
- 2 Participate in an activity involving eco-awareness
- 3 Give an opinion about participating in the activity

This Unit is an optional Unit of the Personal Achievement Award (SCQF level 1) and is also available as a free-standing Unit.
