## Note

In the table that follows, column 1 describes **four** types of qualification being assessed or internally verified and the context for assessment – ie a workplace\* or non-workplace environment.

For each type:

- ◆ Column 2 lists the types of assessor/internal verifier qualifications that those assessing or internally verifying are required to achieve.
- ◆ Column 3 lists the types of assessor/verifier qualification that centres may accept when recruiting new assessor or internal verifiers.

Regulated workplace assessor/internal verifier qualifications such as L&D9, L&D9DI, L&D11 and the equivalent RQF Units must be achieved by:

- ◆ Assessor-candidates conducting assessment in their candidates' workplace
- ◆ Internal verifier–candidates conducting internal verification of assessment carried out in candidates' workplaces

\*Approved Realistic Working Environments (RWE) are deemed to be the candidates' workplace for some SVQ qualification areas. Please consult the Assessment Strategy for the vocational area concerned for further details on whether or not this is permitted.

Note: In all situations it is imperative that assessors/internal verifiers meet the occupational competence requirements specified in the Assessment Strategy/Group Award Specification for the qualification being assessed or internally-verified.
