APPEALS REPORT 2021 SUMMARY



Key points

This release provides information on the number of Appeal requests¹ made following the Alternative Certification Model (ACM) for 2021. There were three grounds upon which an appeal could be submitted: Academic Judgement, Unresolved Administrative Error or Discrimination. This report provides data on the number of appeals in each category and the breakdown of resulting changes². A detailed breakdown of Appeals requests at subject level is provided in 'Appeals Report Tables 2021 Academic Judgement' and 'Appeals Report Tables 2021 Unresolved Administrative Error and Discrimination'.

The key summary points from the release are as follows:

Appeal requests submitted

- There was a total of 3,483 appeal requests submitted³, as follows:
 - 3,265 Academic Judgement appeal requests
 - o 30 under Unresolved Administrative Error appeal requests
 - 188 Discrimination appeal requests

Academic Judgement appeals

- 45 of the 3,265 Academic Judgement requests resulted in a grade change, as follows:
 - o 32 upgrades
 - 13 downgrades

Unresolved Administrative Error and Discrimination appeals

- 31 of the 218 Unresolved Administrative Error and Discrimination appeal requests were upheld. The number requests upheld by grounds for appeal were:
 - Unresolved Administrative Error: 0 upheld.
 - Discrimination: 31 upheld.

- At the point of data collection for this publication, the status⁴ of the 31 upheld Unresolved Administrative Error and Discrimination appeals are:
 - o 12 upgrades.
 - 0 downgrades.
 - 4 no grade change.
 - \circ 15 in progress.

Total grade changes across the three appeal grounds (at point of publication)

- At the point of data collection for this publication, the total number of grade changes across the three grounds for appeals are:
 - o 44 upgrades
 - 13 downgrades

As indicated, 15 appeal requests are still in progress. The outcomes from these, should they result in grade changes, are therefore not reflected in the above numbers.

Type A - Academic Judgement

Appeals were submitted under grounds 'Academic Judgement' where the learner disagreed with the centre's quality assured academic judgement in its assessment of the learner's evidence.

Appeals were submitted under grounds 'Unresolved Administrative Error' where the learner believed that there was an error in either i. transferring the provisional result from the centre to SQA, or ii. SQA processing the result.

Type C - Discrimination

Appeals were submitted under grounds 'Discrimination' by learners in two circumstances:

- i. There has been discrimination or other unlawful conduct contrary to the Equality Act 2010, acknowledged in writing by the centre, or established through court proceedings or by a ruling of the Scottish Public Services Ombudsman (SPSO).
- ii. The centre failed to comply with SQA's requirements for providing assessment arrangements in relation to assessment evidence that contributed to a disabled learner's provisional result.

Further notes

Definition of appeals decisions (not applicable for Academic Judgement)

'Upheld Appeals' were approved for the category under which they were submitted.

'Not Upheld Appeals' were not approved for the category under which they were submitted.

Definition of outcomes and statuses

For Academic Judgement appeals there were three possible outcomes:

- 'Upgrade' appeal request submitted that resulted in a candidate receiving a higher grade.
- 'Downgrade' appeal request submitted that resulted in a candidate receiving a lower grade.
- 'No Grade Change' appeal request submitted that did not result in a change to the grade awarded to the candidate.

For Unresolved Administrative Errors and Discrimination appeals, once an appeal was upheld, there were four possible statuses:

- 'Upgrade' appeal request submitted that resulted in a candidate receiving a higher grade.
- 'Downgrade' appeal request submitted that resulted in a candidate receiving a lower grade.
- 'No Grade Change' appeal request submitted that did not result in a change to the grade awarded to the candidate.
- 'In Progress' appeal request submitted was upheld, but a new grade can only be determined following further actions by the centre/SQA.

All changes are defined with respect to the grade awarded to candidates in the August 2021 Attainment published on 10 August 2021.

An escalated appeals process is available for Unresolved Administrative Errors and Discrimination appeals where either the learner or the head of centre has reason to believe that there has been a procedural irregularity and/or an unreasonable decision in SQA's consideration of the initial appeal. Any changes to the outcome of the initial appeal as a result of an escalated appeal will not be reflected in this publication.
