Note

In the table that follows, column 1 describes **four** types of qualification being assessed or internally verified and the context for assessment, that is, a workplace * or non-workplace ** environment. With the exception of TQFE, all the qualifications listed in the table can be undertaken at SQA-approved centres. For each type:

- Column 2 lists the types of assessor or internal verifier qualifications that those assessing or internally verifying are required to achieve.
- Column 3 lists the types of assessor or verifier qualification that centres may accept when recruiting new assessor or internal verifiers.

Seeking advice on the most appropriate qualifications

For any qualification achieved or being undertaken with another awarding body or Higher Educational Institute and not listed in the table below, please note a decision as to their suitability for the role or assessor and/or internal verifier will be made on a case-by-case basis by SQA awarding body.

Regulated workplace assessor or internal verifier qualifications such as J8RP 04 (CLDLD9D), J8RR 04 (CLDLD9DI), J8RT 04 (CLDLD11SQA) and the equivalent RQF units must be achieved by:

 Assessor-candidates conducting assessment in their learners' workplace Internal verifier—candidates conducting internal verification of assessment carried out in learners' workplaces.

Note:

In school/college or private training provider partnerships, only those members of the Assessment team responsible for the assessment and/or internal verification of assessment decisions of the workplace element of assessment or SVQ units in Foundation Apprenticeships, can work towards the aforementioned Workplace Assessor/Verifier awards.

Those whose role it is to solely assess and/or internally verify assessment decisions of the knowledge and understanding components, would not therefore, meet the criteria of assessment of workplace competence, assessed in the workplace criteria or the internal verification of said assessment decisions.

* Approved Realistic Working Environments (RWE) are deemed to be the learners' workplace for some SVQ qualification areas. Please consult the Assessment Strategy for the vocational area concerned for further details on whether or not this is permitted.

Note: In all situations it is imperative that assessors and/or internal verifiers meet the occupational competence requirements specified in the Assessment Strategy and/or Group Award Specification for the qualification being assessed or internally verified.
