## Note

In the table that follows, column 1 describes two types of qualification being assessed or internally-verified and the context for assessment – i.e., a workplace\* or non-workplace environment.

For each type:

- Column 2 lists the types of assessor/internal verifier qualifications that those assessing, or internally-verifying can achieve (outside of the UK.)
- Column 3 lists the types of assessor/verifier qualification that centres (outside of the UK) may accept when recruiting new assessor or internal verifiers.

## Seeking advice on the most appropriate qualifications

Workplace assessor/internal verifier qualifications such as GT7H 47, GT7L 48 and GT7K 48 must be achieved by:

- Assessor-candidates conducting assessment in their candidates' workplace.
- Internal verifier-candidates conducting internal verification of assessment carried out in candidates' workplaces.

\*Approved Realistic Working Environments (RWE) are also deemed to be the candidates' workplace for some vocational qualification areas. Please consult the Assessment Strategy for the vocational area concerned for further details on whether or not this is permitted.

Note: In all situations it is imperative that assessors/internal verifiers meet the occupational competence requirements specified in the Assessment Strategy/Group Award Specification for the qualification being assessed or internally-verified.
