Guidance has recently been issued on the approach to the National Progression Awards and National Certificates and is applicable for all FAs. As regards the remaining vocational element of each FA, discussions are also taking places with respective sector skills councils. We would hope to offer further guidance on the approach to respective vocational elements of each FA framework at some stage next week.

Please be reassured that the primary objective of both SQA and SDS is to support full FA Certification for all learners who were on track to achieve prior to current restrictions."

FA Group Award Achievement:

Training Provider:

- Q Do we cease delivery against FA's following recent Guidance on NC/NPA?
- A As per recent guidance released by SQA, providers are encouraged to continue learning where possible to further enhance evidence requirements for estimation of NPA and NC components.

OPTIONS APPRAISAL AND PROPOSAL FOR FOUNDATION APPRENTICESHIP CERTIFICATION

Overview:

Further to recent discussions with SQA, both Accreditation and Awarding Body, regarding the impact of Covid-19 on FA learners due to complete this June. This volume of this cohort is circa 1760 learners. As guidance exists for the assessment of the NPA/NC element of FAs this proposal focusses solely on approaches to the SVQ element and FA Certification.

Options Summary:

Further to the guidance on the NPA/NC element, SDS submitted a proposal document to SQA assessing the feasibility for four identified options. These were:

- 1. Continue
- 2. Estimate Plus
- 3. Pause
- 4. Cease

SDS appraisal concludes that only options 1 and 2 comply with the critical parameters identified. However due to significant restrictions in place limited capacity exists to 'Continue' and as such Option 1 is no longer viable, leaving Option 2.

In discussing the potential for Option 2, there are two primary factors to be considered, these are:

- FA Certification: Issuing FA Certificates to learners on the basis of achievement to date and full achievement of all associated units within the overall group award
- SVQ Units: Recognising feedback from skills bodies that estimation cannot be applied for the competency based SVQ units

FA Certification:

It is a breach of existing Awarding Body policy to issue accredited certification for units that have not been achieved. In order to offer FA Certification, SQA would be required to consider the exceptional case for FA and develop an adapted FA Certificate Group Award.

It is recognised that where possible SQA are seeking to avoid the development/issue of Covid-19 Certificates, however is an exceptional case to be made as the only senior phase qualification that as it stands cannot be certified, impacting learner achievement, progression and causing reputational damage to programme.

SVQ Units:

Due to the timing of the Covid-19 and associate disruption to the system, the supply of FA learning was significantly impacted, particularly affecting the work-based learning elements. In addition, the typical holistic assessment strategies employed by providers for SVQ units, subsequently mean there is not tangible evidence of SVQ assessment on SQA systems.

SDS recently circulated a template to their FA providers, requesting them to indicate the extent to which learners have completed the SVQ elements of the programme. Based on approximately 1760 learners, the response captured updates for approximately 1350 (70%).

The information provided identifies that significant progress has been made across most frameworks where students have been accessing work-based learning until restrictions were enforced. Several providers reporting 80/90%+ achievement. A full summary of responses is provided in Annex A.

Given the extent of SVQ achievement, it is important that the solution found recognises this progress both through certification and in progression.

The three primary pathways for FA Learners are University, College or MA. Considering the position of the sector skills bodies, the requirement for practical competency only applies to the MA pathway. SDS through it programme governance and management processes, would therefore ensure that where a candidate from this cohort progresses onto a MA in the same framework, that through associated RPL processes, the candidates are assessment and learning would continue from the stage identified by the receiving employer. University and College progression is less affected by the SVQ component of the FA; however, this requires FA certification to meet existing recognition statements.

Recommendation for Approval:

Based on the information provided above the only solution available to meet unique requirements of the FA programme, is to develop an exceptional FA Group Award Certificate, adapted to reflect achievements, both those assessed to date and that were in progress.

This would only be issued to learners that were on track to achieve the full FA prior to restrictions, guided by the learning providers and in alignment to the approach taken for all other national qualifications.

Further to the guidance on the NPA/NC element, SDS submitted a proposal document to SQA assessing the feasibility for four identified options. These were:

- 3. Pause
- 4. Cease

typical holistic assessment strategies employed by providers for SVQ units, subsequently mean there is not tangible evidence of SVQ assessment on SQA systems.

SDS recently circulated a template to their FA providers, requesting them to indicate the extent to which learners have completed the SVQ elements of the programme. Based on approximately 1760 learners, the response captured updates for approximately 1350 (70%).

To support the proposal / solution for FA certification within this paper, SDS and SQA would gather comprehensive evidence of assessment captured to date from all FA Learning Providers / Centres, in line with current assessment strategy guidance and standards.

Considering the position of the sector skills bodies, the requirement for practical competency only applies to the MA pathway. SDS through it programme governance and management processes, would therefore ensure that where a candidate from this cohort progresses onto a MA in the same framework, that through associated RPL processes, the candidates are assessment and learning would continue from the stage identified by the receiving employer. University and College progression is less affected by the SVQ component of the FA; however, this requires FA certification to meet existing recognition statements.

Recommendation for Approval:

Based on the information provided above, and conversations with SQA to date, the only solution available to meet unique requirements of the FA programme, is to develop an exceptional FA Group Award Certificate, adapted to reflect NPA/NC group awards and any of the SVQ units already achieved.

This adapted certificate would be issued to all learners that were on track to achieve had it not been for the disruption caused by Covid-19, as guided by evidence from the learning providers/centres and in alignment to the criteria / principles agreed for other national qualifications.

MINISTERIAL UPDATE ON FA CERTIFICATION FOR COVID-19 AFFECTED LEARNERS

15 May 2020 Update

Progress in last week:

- Feedback from SQA on the SDS proposal for Option B solution was provided on 10th May.
- Meeting with SDS and SQA senior staff held on 15th May to discuss feedback and SQA response that highlighted the key reasons why this proposal was not considered the best solution. The meeting explored the SDS comments and questions to this response.
- A variant of the proposal for Option C solution was discussed and is updated in the Table 1 below.
- The actions and next steps agreed to progress with urgency are summarised in Table 2 below.
- Meeting between SDS / SQA next week to progress action plan and agree timescales for finalising solution and communication plan for key stakeholders.

Current RAG Status:

AMBER – solution

RED - timelines

Contingency solution sought:

All FA learners on track to achieve and complete their FA to receive certification, in line with all other Senior Phase L6 qualifications, where contingency solutions have been agreed and communicated in response to the significant disruption due to COVID-19.

Summary:

- Circa 1760 Learners remain on the FA programme due to complete in June 2020.
- Covid-19 restrictions to work-placement have impacted the providers/learner's capacity to complete elements of the SVQ units within each FA Framework.
- SQA guidance has been issued to apply 'estimation/professional judgement' for National Progression Awards or National Certificate element of each FA, in accordance with guidance being applied for National and Highers.
- Sector Skills Bodies asked for their view on options for the remaining SVQ elements of FAs. This has confirmed that 'estimation' cannot be applied due to the competency-based assessment requirements for SVQs.
- Feedback from providers suggesting significant degree of SVQ learning undertaken. However due to holistic assessment with all units finalised at the end of delivery, this progress is not captured on SQA systems.

SDS Proposal(s):

In discussions with SQA, SDS has identified and proposed the following options for consideration outlined in Table 1.

PROPOSAL FOR FOUNDATION APPRENTICESHIP CERTIFICATION

Summary Overview:

- Circa 1760 Learners remain on the FA programme due to complete in June 2020
- Covid-19 restrictions to work-placement have impacted the providers/learner's capacity to complete elements of the SVQ units within each FA Framework
- Solution required to ensure learners on track for achievement are not disadvantaged
- Solution required to retain confidence in FA for Year 2 returners and new starts in August 2020
- Weekly ministerial updates to Scottish Government on progress toward a solution

Covid-19 FA Impact:

The disruption caused by Covid-19 to learning and the completion of senior phase qualifications, has required significant innovation and adaption in order support certification for learners. For Highers and Nationals, providers are applying 'professional judgement', backed by evidence, to estimate the learners most likely outcome. This approach has provided the solution for most senior phase qualifications, enabling certification.

Due to the unique composition of Foundation Apprenticeships however, this estimation guidance can only be applied to the NPA/NC element. It cannot be applied for vocational units, where practical competency is required to support validation. This concludes that existing FA certification cannot be applied to students that were on track to achieve. Failure to identify an appropriate solution will significantly disadvantage FA learner achievement and respective progression pathways to FE, HE and work.

SDS/SQA Engagement:

Following the Scottish Government commitment, that no learner achievement and progression should be disadvantaged due to the impact of Covid-19, SDS and SQA have committed to delivering a solution for FA learners due to complete this academic year. The following thee objective were identified:

- Learners are certified for all completed components of the programme
- Learners are recognised that they were on track to achieve the full FA prior to the disruption
- Learner progression to FE, HE and work is not disadvantaged

SDS/SQA Proposal:

Recognising the unique difficulties for certification faced by the Foundation Apprenticeship programme, SDS and SQA propose the following solution.

FA Certification & Progression Proposal:

This proposal is aligned to FA learners that were due to complete their respective qualification this academic year 19/20.

The following categories of learners are recognised:

- 1. FA Learners that have achieved the full FA Award
- 2. FA Learners that were on track to achieve the full FA Award
- 3. FA Learners that were not on track to achieve the full FA Award
- 1. FA Learners that have achieved the full FA Award:
 - Learners who have achieved all units of their Foundation Apprenticeship will receive the existing FA full award
 - FA Qualification is recognised within eligibility for college HN provision as per existing published specifications.
- 2. FA Learners that were on track to achieve the full FA Award:
 - Learners that were on track to achieve are identified as follows:
 - Learners who have passed the NPA/Nc element of the programme
 - Learner that had no fails recorded with SQA against any of the respective vocational units
 - Learners will receive certification for the units/NPA/NC Group Award already achieved
 - In addition, learners will receive a 'Letter of Recognition' from SQA attesting that had it not been for the disruption and interruption of Covid-19, the learner was on track to achieve the Full FA award.
 - The 'Letter of Recognition' is recognised as evidence of FA achievement and meets the requirements for eligibility for college HN provision as per existing published specifications.
- 3. FA Learners that were not on track to achieve the full FA Award
 - All remaining Learners who have achieved individual units of their Foundation Apprenticeship will be certified via existing SQA processes but will not receive the Letter of Recognition.

Recommendation for Approval:

To deliver on the proposal outlined above, SDS and SQA requires college sector endorsement and approval of the 'Letter of Recognition', both in terms of the validity of the approach and in terms of aligning it to existing FA eligibility for college HN provision.

SDS and SQA have been greatly encouraged following the initial consultation with sector representatives on 20 May 2020, and now seek formal approval form the sector.
