Subject: Timetable and percentages

Hi Fiona,

We have considered the examination timetable and current entries (as of yesterday) and produced what you were after. As this uses current entries, the raw numbers are a bit higher than we are likely to see during live, but as percentages, should be sensible and a reasonable estimate. This shows the daily entries we will have got through, the cumulative totals and percentages (since the first day), and the final overall cumulative entries that will have taken/completed examinations (assuming all candidates are able to sit).

The end of weeks are in red, so at end of week 1 we will have seen approx.. 18.3% of entries/assessment, by end of week 2 approx. 40.8% etc. Interestingly, although these are some differences by level, by the end of week 3, we will have over 70% of the entries/assessment materials in. as most of the big subjects are early in the assessment period.

You will note at the bottom of the file we have some quals with no exam component in the exam period.
