I am writing to you in your position as regarding the publication of the results of the Higher History survey, further to our discussions earlier this week. I am also writing to you in my position as Director of Qualifications Development with a duty of care and responsibility for the health, safety and wellbeing of colleagues within SQA.

When the survey was published, teachers' personal information was not disclosed. However, the same care was not taken with the names of SQA staff or appointees who were subject to comments that were unsubstantiated and potentially defamatory. We are extremely disappointed and concerned by this as it has caused significant personal distress to colleagues.

One example of this is the naming of our responsible for the processes and procedures (set by the organisation), not the content of the question papers or the marking. This is done by teachers. One respondent says: 'The rot, in my opinion, started since in 2019. Look at the declining results since then. This infers that the remit extends beyond that of the processes and procedures that she is responsible for and also makes unacceptable calls for her to lose her job. As the Higher History Review makes clear, the and others involved with the Higher History assessment and awarding processes acted with integrity at all times.

I recognise that, in the interests of transparency and openness, it is important for SATH to share the survey results but that should not extend to the naming of individuals. I require that:

- any personal information in the survey results (which either names them directly or includes information which allows them to be identified) is redacted immediately;
- that any versions that contain this personal information are removed from websites, social media or other platforms and replaced by redacted versions;
- that SATH members are asked not to make any further use of the unredacted survey results or share them;
- that SATH publicly apologises to colleagues named in the survey results and publicly acknowledges that this personal information should not have been published.

Please confirm to me by Friday 13 December 2024 that these steps have been taken.

I am writing to follow up on our initial conversation from December 16, 2024, where we discussed several issues concerning Higher History. During that meeting, we identified and

agreed two key actions that you would take forward: sending a draft apology and providing

redacted survey responses for me to share with

It has now been over a month, and despite repeated assurances from you that you would follow up on the agreed actions, these have not transpired. While I acknowledge that the Christmas holidays were part of this period, this ongoing delay is unacceptable. I have a duty of care to as a colleague in my team, and as an employee of SQA, and I am deeply concerned about the impact this delay is having on health and wellbeing.

I am concerned that each time we discuss, you commit to sending me the documentation then fail to do so. This circular situation and ongoing repetitive correspondence cannot continue. I must stress the urgency of this matter and request that you issue the documents by cob Monday 20 January.

I would like to offer you an invitation to have further meeting with me on Tuesday 21 January at 8:20 AM to discuss the draft documents and ensure they can be published by cob of the same date.

Thanks for this – it is indeed a very stressful situation, and not, I would argue, one of my making. Let's go with the original apology – it seems clear that is not going to accept any apology given as I have now written four, including one that was sent to her personally which she has not acknowledged or responded to. I am genuinely sorry that her name was included in the shared version of the survey, it was an oversight and not intended to cause harm or upset. It was removed immediately and an apology issued on the day that it was brought to my attention, and this should have been the point where we moved on and focussed on the issues that the survey has highlighted.

I met with the committee last night, and we have agreed, after also seeking advice on this issue, that the survey will be shared with names and job titles redacted. We are unable to remove all of the comments suggested, it would amount to censoring the opinions of teachers after promising that we would not do this. Whilst the survey certainly makes for uncomfortable reading in places, it represents honestly held opinions of the History teaching community. It represents a range of views, and in sharing it SATH are not endorsing or aligning with any of the comments made. Our intention was and is to try to find a way forward, and we were and continue to be keen to work with SQA on this.

I am happy to discuss tomorrow morning.

The original apology, shared on Facebook and the History teachers Team on 13<sup>th</sup> December:

SATH would like to apologise for the release of the Higher History survey results with a member of the SQA team named in one of the comments. This was an oversight and no harm was intended. The survey was anonymised for History teachers and the same courtesy should have been afforded to members of the SQA team, and I take personal responsibility for this mistake. We are sorry for the distress that this has caused. Names and job titles have now been redacted from the survey. We would ask that anyone who has saved the previous version of the survey deletes it and does not share it further.

The last part has been changed slightly as it will be shared alongside the amended survey. I have added a further apology for the distress caused. This really needs to move on.
