





I'm writing to ask for your approval of an adjustment to the Higher History Report in response to feedback from our Board of Management. The adjustment is presentational and does not affect the substance or conclusions of the report.

In summary our Board has expressed reservations about the use of the term 'Recommendations' in the report. To reflect this feedback we now propose to use the term 'Wider reflections' for this section and to add the following introductory text before the list of points:

'While beyond the immediate scope of the review, some wider reflections have emerged during the review process. There are areas for continuous improvement which could strengthen the way the education community works together during the assessment and awarding process and which could also support learning and teaching.'

The text of the recommendations/wider actions remains unchanged.

Could you please let me know if you are comfortable with this adjustment? If so, for consistency we will amend your endorsement statement so that it refers to 'wider reflections' rather than 'Recommendations'.

Also in response to feedback from our Board we have produced a short, summary version of the report that will be published with it. The text of the summary is taken from the main report. I have attached a late draft of this summary version for your information.



- Stage 2 Markers are practising teachers and lecturers and SQA is dependent on them to mark over 1.3 million graded National Course exam scripts, assignments and coursework every year.
- Stage 4 Standardisation is led by the Principal Assessor and supported by their senior team leaders and team leaders. Its main purpose is to finalise the detailed marking instructions based on a review of a sample of responses from learners who have sat the question papers and completed coursework.

 Stage 8 - Grade boundary meetings determine the minimum marks needed to get an A, B, C, or D grade or a 'No Award' result. Grade boundaries help ensure assessments have worked as planned and that standards are consistent from one year to the next. Every year we review how each course assessment has performed in order to set grade boundaries fairly.

With regards to the mention of 'for subjects that are marked from paper' at the marker check and finalisation stages – Richard has suggested that for the purposes of this publication, we say:

- Marker check (for example for Higher History)
- Finalisation (for example for Higher History)

The review report, published yesterday, concludes that the standard in 2024 was the same as that set in previous years. The report confirms that the Higher History exam team acted with integrity throughout the awarding process.

I hope the outcome of the review, which has been independently scrutinised and endorsed by an external awarding body, will reassure learners, parents, carers, teachers, lecturers and the wider public that they can have full confidence in our assessment and awarding processes.
