

Prepare Work Area for Picking and Packing Orders in Food Manufacture

Unit Summary

This Unit is about preparing the work area for picking and packing orders in readiness for despatch in food and drink manufacturing. It covers preparing the work area for collating and packing which involves keeping the work area clean, wearing the correct personal protective clothing and preparing equipment.

This Unit is for you if you work in food and drink operations and your job requires you to pack orders of products in readiness for despatch.
