Outcomes 1 and 2

Candidates can record aspects of their multi-track recording at home. However, this should be agreed in advance, to ensure that the evidence requirements are met.

Music Business: Communication Skills (SCQF level 7) J00W 34

Outcome 1

Evidence can include candidates participating in a virtual networking event.

Outcome 2

Candidate's participation in a music industry negotiation can take place on an online virtual platform, where the assessor can attend and observe. Alternatively, they can record the negotiation.

Music Business: Releasing a Record (SCQF level 7) J0M4 34

You can contextualise all evidence requirements for an online music release, as a physical release is not required. However, candidates can manufacturer physical copies and distribute if this format of release is selected.

Sound Production: Sound for Live Events (SCQF level 7) J01C 34

As part of learning and teaching you can use virtual soundchecks, where multi-channel audio material is replayed through the sound reinforcement system, to allow simulated sound checks and mixing for live events.

During a virtual soundcheck, candidates must be in the same room as the sound reinforcement system. They can use pre-recorded multi-channel material as an alternative to a live band being present.

A virtual soundcheck must not be used during assessments.

Outcome 3

If you are delivering the optional unit Sound Production: Acoustics (SCQF level 8), partial integration opportunities exist between aspects of outcomes 1 and 3 of this unit.

Sound Production: Digital Audio Workstations (SCQF level 7) J019 34

You can integrate assessment for this unit with the Sound Production: Recording and Mixing (SCQF level 7) unit. Integration is also possible with the optional unit Audio Post Production: An Introduction (SCQF level 7).

Sound Production: Digital Audio Workstations (SCQF level 8) J01D 35

You can integrate assessment with optional units, such as Sound Production: Independent Studio Project (SCQF level 8) and Sound Production: Creative Music Re-mixing (SCQF level 7).

You can integrate assessment with Sound Production: Graded Unit 2 (SCQF level 8).

Sound Production: Sound Reinforcement (SCQF level 8) J0LR 35

You can achieve holistic assessment of this unit by using one sequence. Candidates must use an arrangement of compositional elements, use editing functions to correct identified technical errors and produce a mix of the MIDI sequence.

In the holistic assessment, candidates must meet all evidence requirements associated with individual outcomes.
