Assessment approaches

Most centres used published SQA unit assessment support packs or appropriately adapted unit assessment support packs.

Assessment judgements

Centre judgements were generally in line with accepted standards. Where appropriate, centres provided supportive comments.

Section 3: general comments

Most centres demonstrated a secure understanding of the assessment standards and candidates were well prepared for the assessment. Centres are reminded that for National 4, SCQF level 5 and SCQF level 6 units, candidates can achieve outcome 1 in the Life in Classical Greece unit and the Life in the Roman World unit if they gain two out of three assessment standards.

When adapting or creating assessments, centres should ensure that all the relevant documentation is included with the submission. The submission should include the assessment task and the judging evidence table.

Submitting prelims in place of unit assessments can result in candidates not achieving the assessment standards as the skills of the assessment standards are demonstrated in a different way from the skills in the question paper. For example, the assessment standards for outcome 1 for Life in Classical Greece (SCQF level 5) require candidates to use a source of evidence when drawing comparisons with the modern world whereas the question paper for National 5 does not use a source of information for making comparisons with the modern world.
